Risk assessment for COVID-19

The questions below will enable OCs to review the additional considerations specific to sports, and thus inform their risk assessment of COVID-19 associated with their Event. This will help OCs understand and manage any additional risk from COVID-19.

The risk assessment should be reviewed and reassessed regularly during the planning phase and updated immediately prior to the transition to the operational phase, especially in light of the rapidly evolving nature of the outbreak. Reference should be made to the latest technical guidance and situation reports on the WHO website.

The risk assessment for COVID-19 associated with the Event must be coordinated and integrated with the host country's national risk assessment for COVID-19. The person completing the questionnaire should include input from the local public health authorities, consult WHO's latest technical guidance and ensure that there is an up-to-date evaluation of the epidemiological situation.

Mitigation checklist for COVID-19

"Saumur Attelage" event from June 2 to June 6, 2021

These measures are applied during the event held in Saumur, from 2 June to 6 June 2021.

These measures were established on May 12, 2021 and may change based on government recommendations. The event takes place only outdoors. Wearing a mask is mandatory. The event will be open to the public, with a gauge of 1000 people per day, excluding leaders and volunteers. The following schedules cover meal times, the reception of volunteers, competitors and their entourage and the briefing of volunteers.

Appendix 1: Volunteer Home

Volunteers will be received in the "Volunteer Home" space. Outside, people must wear the mask and put as soon as possible, 1 meter of physical distance. Upon arrival, the volunteers receive a mask.

Arrival: An entry register must be completed by each person wishing to enter the site. There will be a temperature check of the volunteers as soon as they arrive. The committee will send information upstream on the health measures put in place on the event. This information will be recalled at the volunteer briefing. Posters on barrier gestures, and good behaviors will be displayed on the walls.

Restoration: We plan two solutions: takeaway meals OR (if sanitary conditions permit) cafeteria meals according to pre-set schedules.

Wearing a mask is mandatory during the service. All volunteers are asked to respect 1 meter away between them, and to sit down. The direction of traffic must be respected.

Housing: The committee is not responsible for housing its volunteers.

Sanitary: they will be cleaned twice a day with certified products.

Hydroalcoholic gel will be available at different event locations, and regular hand washing is required.

Violation of the rules: Anyone who does not comply with health rules will be excluded from the site.

Appendix 2: Home of leaders, grooms and entourage

Before June 1, 2021, each leader must register, along with the persons accompanying him, before they arrive on the site, and must complete and return the entry form (attached) to the email address: saumur.attelage@orange.fr. No entry to the site will be accepted without a return of this completed form. A quick covid test - from 72 hours will be checked at the entrance for each person of the team. Upon arrival, at the reception of the boxes, the team with the horses will have to present themselves with the passport of the horses to obtain the envelope containing the competition numbers, accreditations and health protocol that must be followed during the team's stay. Please read it carefully.

Upon arrival, accreditation bracelets will be distributed according to your status, which will be worn throughout the stay and presented whenever requested. Wearing a mask is mandatory throughout the site.

Arrival: An entry register must be completed by each person wishing to enter the site. On their first arrival, a temperature will be taken at the entrance to the site. At the beginning of the event, a meeting will be held to remind people of the health rules to be followed. Leaders and their teams are required to use only their own equipment.

Training areas: access will be limited to respect social distances on competition days. Only the team, wearing a mask, will be able to accompany its leader on the warm-up areas. The direction of traffic will have to be respected by the competitors and their team. Those authorized to the stables will have to respect the areas assigned to them.

Sanitary: they will be cleaned several times a day with certified products. Hydroalcoholic gel will be available at different event locations, and regular hand washing is required.

Meals: Each leader is responsible for his own meals, and those of his team. There will be a takeaway restaurant, possible on site.

Return: The medical service offers PCR tests, on a designated location, on Friday afternoon, June 4, 2021. There is an additional fee (60 euros) for foreign leaders and their team. They will have to notify it in the entry form, whether or not they wish to take the test.

Violation of the rules: Anyone who does not comply with health rules will be excluded from the site. The competitor and his team will be banned from competition and without reimbursement of the fees.

Annexe 3: Treatment of Covid-19 cases

For all detected cases of Covid-19, the organization must be informed immediately and immediately. A Covid-19 crisis cell will be present at the site, in conjunction with the ARS throughout the event.

Symptomatic cases:

1. Immediate return of the person to his dwelling, if there is an impossibility, the person will be confined to a space provided for this purpose, on the site. The medical services will take care of it.

Proven cases:

1. As soon as the case is proven, the organization should be informed immediately.
2. Informing known contacts
3. A return to the site possible on presentation of the favorable opinion of the doctor only.
4. Cleaning the isolation cell.

responsibility:

The spread of the virus depends on the responsibility of each person, and respect for the barrier gestures. Naturally, everyone is asked not to show up at the event if there are suspicious signs of Covid-19 shape. After the event, it will be imperative to notify the organization, if you learn that you are positive at Covid-19. This will allow the organizers to notify as quickly as possible, all people who may have been in contact. All these sanitary measures are indicated to ensure our safety, and to ensure the continuity of equestrian competitions.

Thank you for committing to respecting these essential rules! In this context, we invite you to keep a friendly spirit, and above all a sportsmanship!

2 – 6 JUIN 2021

The organizing committee is pleased to welcome you from June 2 to 6, 2021. To prevent the impact of COVID-19 and EHV VIRUS during the event, here are the instructions to follow:

COVID – 19

1 – All competitors and teams must perform a quick PCR test less than 72 hours before their arrival. It will be checked by a steward at the entrance (except vaccinated 1 or 2 vaccines, who bring a certificate). The whole team has to arrive at the same time.

2 - The quick test is for everyone.

3 – Maximum personnes allowed per team:

Single Horse/Pony: 1 driver, 3 Accompanying persons

Pair Horse/Pony: 1 driver, 4 Accompanying persons

Team Horse/Pony: 1 driver, 5 Accompanying persons

Children up to the age of 10 are accepted in addition to, with a test.

4 – arrivals are only possible on Tuesday, June 1

H4 – P4 → 8 a.m. to 11 a.m.

H2 – P2 → 11 a.m. to 3 p.m.

H2 – P1 → 3 p.m. to 5 p.m.

5 – it is not possible to arrive on Wednesday, June 2

6 – If necessary, leaving the site is allowed

7 – authorized persons per nation: 1 trainer, 1 chef d'équipe, 1 veterinarian; these people must have done the quick test and present it when they arrive on Tuesday

8 – no one will be accepted on the site if they do not have their test

9 – mandatory mask obligatory on site.

EHV – virus

As a precaution, the grooms will have to take the temperature of their horses/ponies at the entrance of the boxes, with passport checks. If a horse/pony has temperature, it will be put under observation with all horses team.

III. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

NB: Horses entered in CIMs in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (GRs 137.2).

Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated, or fail to meet other passport requirements will be **subject to Sanctions in accordance with Annex VI of the Veterinary Regulations** and may not be allowed to compete.

NB for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

7.2 VACCINATIONS - EQUINE INFLUENZA. FEI Veterinary Regulations Article 1003

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

VACCINATION	PROTOCOL	ELIGIBILITY TO ENTER VENUE
Primary Course	1 st Vaccination: day 0 2 nd Vaccination: day 21-92	May compete 7 days after the 2 nd Vaccination
First Booster	Within 7 months of the 2 nd vaccination of the Primary Course	May compete for 6 months +21 days after the 2 nd vaccination of the Primary Course Must not compete in the 7 days after receiving a vaccination
Boosters	MINIMUM: within one year of previous booster vaccination IF COMPETING: must be in the 6 months +21 days of the booster previous vaccination	Must have been vaccinated within 6 months +21 days before arriving at the Event Must not compete in the 7 days after receiving a vaccination

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the relevant territory.

7.3 EXAMINATION ON ARRIVAL. FEI Veterinary Regulations Article 1031

On arrival at an Event venue all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

7.4 HORSE INSPECTIONS. FEI Veterinary Regulations Articles 1034-1042

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

7.5 LIMB SENSITIVITY EXAMINATION. FEI Veterinary Regulations Articles 1048-1053

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event.

For Jumping that includes, but is not limited to, between rounds and before the Jump Off. For Endurance that includes, but is not limited to, pre-ride, during the ride and after the ride. Horses may be examined once or on multiple occasions during the Period of an Event.

Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

8. EQUINE ANTI-DOPING AND CONTROLLED MEDICATION PROGRAMME (EADCMP). FEI Veterinary Regulations, Chapter VII

8.1. SAMPLING. FEI VETERINARY REGULATIONS Chapter VII

All horses competing at FEI Events may be subject to sampling for the presence of Prohibited Substances in accordance with the Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

8.2. ELECTIVE TESTING. FEI VETERINARY REGULATIONS ARTICLE 1058

Elective Testing may be carried out prior to an Event to check for the presence of Prohibited Substances. Please refer to <https://inside.fei.org/fei/cleansport/horses> for information and details.

XIII. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEIs' Anti-doping Rules for Human Athletes (ADRHA)

XIV. ADDITIONAL INFORMATION

1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic ("Policy") <https://inside.fei.org/fei/covid-19/return-to-play/policy-tools> is mandatory and applies for any FEI Event taking place **as of 1 July 2020**. The Policy has been developed based on currently accepted best practices by the WHO and US Center for Disease Control (CDC) and will be continually reviewed and updated as more information becomes available. It is not intended to replace the applicable guidance and policies from domestic government and health authorities, but to supplement their recommendations with sport specific considerations.

The OC shall submit the risk assessment and mitigation plan (including name and contact details of the person in charge) to the FEI as an annex to the Event Schedule, **at the latest ten (10) working days before the event's deadline for Definite Entries.**

Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy **will be removed from the FEI calendar** in accordance with Article 112.3 of the FEI General Regulations.

ASSUMPTION OF RISK / WAIVER OF LIABILITY

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,
3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
4. The Participants, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners

and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.

2. INSURANCES AND NATIONAL REQUIREMENTS

Equestrian sports involve inherent dangerous risks. To the greatest extent permitted by law, the FEI and the FEI Event Organiser shall NOT be liable for any damages relating to loss of property or injury of any kind to Athletes, Owners, Support Personnel or Horses at or in connection with an FEI Event and the FEI expressly excludes all such liability.

2.1. ATHLETES, OWNERS AND SUPPORT PERSONNEL

2.1.1. Personal Accident and Health Insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

2.1.2. Personal Property Insurance

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

2.1.3. Press Equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

2.2. ATHLETES AND OWNERS

2.2.1. Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation

to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

2.2.2. Additional Liability Information

2.2.3. Horse Insurance

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

3. PROTESTS/APPEALS

To be valid, all Protests and Appeals must be made in writing and accompanied by a deposit of CHF 150.- or equivalent.

4. DISPUTES

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

5. MODIFICATION TO SCHEDULE

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Foreign Judge.
